SUMMARY OF THE PROCEEDING OF THE 32ND ANNUAL GENERAL MEETING

The 32nd Annual General Meeting (AGM) of the Members of Superior Industrial Enterprises Limited was held today i.e. Thursday, 21st September, 2023 at 03:00 PM via two-way Video Conferencing (VC)/ Other Audio Visual Means (OAVM) and deemed to be held at the registered office of the Company located at 25 Bazar Lane, Bengali Market, New Delhi DL 110001 IN. The Company, while conducting the Meeting, adhered to the circulars issued by the Ministry of Corporate Affairs (MCA), the Securities and Exchange Board of India (SEBI).

The following Board of Directors and Key Managerial Personnel were virtually present at the meeting:

3. Ms. Kusum Sharma, Non-Executive - Independent Director

Mr. Krishna Kumar Agarwal, Non-Executive - Non Independent Director was present physically in the meeting at the registered office of the Company. In accordance with the provisions of Companies Act, 2013 and Secretarial Standards - 2 on General Meetings, Mr. Kamal Agarwal was elected as the Chairman for the meeting to conduct the proceedings.

A total of 46 Members joined the meeting through VC/OAVM

As per Section 103 of the Companies Act, 2013, the required quorum for convening the AGM was present and complete and accordingly, Ms. Kajal Garg, Company Secretary cum Compliance Officer of the Company, with the approval of the Chairman called the meeting to order. Since there was no physical attendance of Members and in compliance with the Circulars issued by MCA and SEBI from time to time, the requirement of appointing proxies was not applicable, except for the authorized representatives of corporate shareholders.

Ms. Kajal Garg, Company Secretary cum Compliance Officer of the Company, with the permission of the Chairman commenced the proceedings of the Meeting and requested each Director and Key Managerial Personnel to introduce themselves.

Mr. Loveneet Handa, Partner at M/s RSH & Associates, Secretarial Auditor and Scrutinizer, Mr. Ankit Jain, Partner of S. Jain and Co, Statutory Auditors of the Company, Mr. Kamal Gupta, Proprietor of M/s Gupta Kamal & Co., Internal Auditor of the Company, were also present at the Meeting through VC.

Ms. Kajal Garg, Company Secretary cum Compliance Officer of the Company, informed the members that the Register of Directors and Key Managerial Personnel and their Shareholding and Register of Contracts or Arrangements in which Directors are Interested are available. These will remain accessible to the members for inspection electronically if they so desire.

With the consent of the Members, the Notice of the Meeting was taken as read. The Members were informed that the Statutory Auditors' Report, Secretarial Audit Report, Cost Audit Report, Internal Audit Report for FY 2022-23 did not have any qualifications / adverse remarks / disclaimer / reservation.

The following items of business as set out in the notice convening 32nd AGM were placed for members consideration and approval.

Ordinary Business:

1. To receive, consider and adopt the:
 - a) Audited standalone financial statements of the Company for the financial year ended 31st March, 2023 and the reports of the Board of Directors and the Auditors thereon; and
 - b) Audited consolidated financial statements of the Company for the financial year ended 31st March, 2023 and the reports of the Auditors thereon;
2. To appoint a Director in place of Mr. Krishna Kumar Agarwal (DIN: 06713077) who retire by rotation and being eligible, offer himself for re-appointment.

Special Business

3. To ratify the remuneration of M/s Mahesh Singh & Co., Cost Auditor of the Company for the year 2023-24
4. Approval for Related Party Transactions

The Members who had pre-registered with the Company as speakers were invited to express their views, ask questions and seek clarifications on the operations and financial performance of the Company and on the resolutions set out in the Notice. The Members were given an opportunity to speak in the order in which they had registered their names.

Thereafter, it was informed that Mr. Loveneet Handa, Practicing Company Secretary was the Scrutinizer appointed by the Board to scrutinize the votes cast during the Meeting and through remote e-voting, in a fair and transparent manner.

Ms. Kajal Garg, Company Secretary cum Compliance Officer, informed the members that the Company had provided its Members the facility to cast their vote electronically through the National Securities Depository Limited ('NSDL') system before the Meeting through remote e-voting. She further informed that the e-voting facility was also made available during the AGM for the benefit of Members who were present during the Meeting and had not cast their votes earlier through remote e-voting. Time allotted for this purpose was 15 minutes from the closure of meeting.

Ms. Kajal Garg, Company Secretary cum Compliance Officer, carried out the voting process and concluded the Meeting. She further informed the Members that the combined results of the remote e-voting before as well as remote e-voting during the AGM would be announced within two working days of the conclusion of the Meeting and the results alongwith the Scrutinizer's Report would be intimated to the Stock Exchanges in terms of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and would be placed on the website of the Company and NSDL.
