New Delhi, July 18: Employees who fail to buy air tickets at the lowest price available on the day while undertaking journey on Leave Travel Concession (LTC) claim will face severe penal action, as per the

draft guidelines finalised by the Centre.

The move comes after the government noticed instances where some of its employees colluded with private travel agents to submit LTC claims showing inflated air fare to clandestinely obtain undue benefits like free boarding, lodging, transport or cash refunds. The CBI is also looking into cases of alleged irregularities in availing the LTC claims. PTI
