पीडीएफ पर निर्भर है राज्यसभा सीट का गणित

उत्तराखंड में राज्यसभा की सीट के चुनाव का सारा गणित पीडीएफ पर निर्भर है। कांग्रेस और भाजपा पीडीएफ के दम पर ही इस राज्यसभा सीट को जीत पाएंगे। कांग्रेस के इस सीट पर प्रत्याशी घोषित करने से पहले पीडीएफ की राय न लेना कांग्रेस को फिलहाल भारी पड़ता नजर आ रहा है।

सूत्रों के अनुसार पीडीएफ ने अपनी नजरंदाजी से नाराज होकर दिनेश धने को अपना प्रत्याशी बनाया है, उससे सरकार में बैचेनी बढ़ गई है। हालांकि, पीडीएफ की एकता को लेकर भी संशय चल रहा है। पीडीएफ के सदस्य हरीश चंद्र दुर्गापाल को मुख्यमंत्री का करीबी माना जाता है। बसपा हाल ही में शक्ति परीक्षण के दौरान पीडीएफ से

दूरी बनाते नजर आई थी। ऐसे में पीडीएफ की एकता ही उसकी सफलता की कुंजी साबित होगी।

प्रदेश में राज्यसभा की सीट के अंक गणित में अभी तक कांग्रेस सबसे मजबूत स्थिति में मानी जा रही थी। पीडीएफ के सरकार में शामिल होने के कारण इनके छह वोट भी कांग्रेस के पाले में जाने तय माने जा रहे थे। पीडीएफ में तीन निर्दलीय, एक उक्रांद और दो बसपा के सदस्य हैं। इस कारण संख्याबल में कम होने के बावजूद कांग्रेस प्रत्याशी का इस सीट पर जीतना तय माना गया।
